VOTE Māori Affairs

OVERVIEW

Appropriations sought for Vote Māori Affairs in 1999/2000 total \$55.224 million. This is intended to be spent as follows:

- \$25.770 million (46.7% of the Vote), for policy advice on the Crown's relationship with iwi, hapu and Māori, and advice on promoting increases in the levels of achievement attained by Māori with respect to education, health, economic resource development, and employment and training.
- \$7.116 million (12.9% of the Vote), for facilitation of local services.
- \$4.225 million (7.6% of the Vote), for providing services to the Māori Trustee.
- \$4.455 million (8.1% of the Vote), for the Māori Development Commissions.
- \$0.146 million (less than 1% of the Vote), for management of the Māori Reserved Land Amendment Acts 1997 and 1998.
- \$1.080 million (2% of the Vote), for the activities of the Board and management team administering the Māori Pre-Commercial Facilitation Service.
- \$9.044 million (16.4% of the Vote), for payments to Māori individuals and organisations.
- \$3.258 million (5.9% of the Vote), for lending programmes.
- \$0.130 million (0.2% of the Vote), for payments to the Housing Corporation of New Zealand.

Crown revenue sought for Vote Māori Affairs in 1999/2000 totals \$6.222 million.

Details of how the appropriations are to be applied appear in Parts B1, C, D and E of this Vote. Details of Crown revenue appear in Part F.

Part A - Statement of Objectives and Trends

Part A1 - Objectives for Vote Māori Affairs

Desired Government Outcomes

The Government's policy goals and priorities are outlined in its document *The New* Zealand Government's Goals and Priorities 1999-2002, released on 9 December 1998. The main goals and strategic priorities include the Government's aims for education, health, the economy and Māori outcomes.

Goals relating to Māori

When setting goals and priorities for the next three years, the Government stated:

"Recognising the importance of the Treaty of Waitangi, we will ensure that through Government's policies and actions we continue in good faith to build relationships between the Crown and Māori. In order to achieve this, we are committed to continuing the significant progress already made in negotiating and implementing fair, durable and affordable settlements of historical grievances, and improving the social and economic status of Māori."

In order to achieve this goal, the Government identified the following priority:

"To extend economic and social opportunities by significantly improving the health, employment, education and housing status of Māori."

Output Classes

The appropriations in Vote Māori Affairs will contribute to meeting the Government's obligations and objectives for Māori. They will resource:

Strategic leadership advice

This includes:

- strategic policy advice to the Government on Māori development issues and on the Crown's ongoing relationships with iwi, hapu and Māori
- monitoring the performance of mainstream government departments to assess the impact on Māori of the policies they develop and administer, and give advice to departments on the design and development of monitoring systems for this purpose

- facilitating consultation between the Crown, its agencies, and iwi, hapu and Māori, on policies affecting Māori, and the development of the relationship between the Crown and Māori
- informing Māori on mainstream departments' responsibilities for designing and delivering policies which meet their circumstances.

Advice on sectoral issues

This includes:

- providing advice, alongside the principal mainstream departments, on the design and implementation of policy as it affects Māori. This covers the four main areas of education, training and employment, health and economic resource development, including advising on inter-sectoral issues
- commenting on and contributing advice on other policies developed by mainstream departments that will satisfy government objectives in respect of Māori
- monitoring and analysing outcomes and trends in the areas of importance to Māori development which are indicated in the Ministry of Māori Development Act 1991 and communicating these results to iwi, hapu and Māori, and working with other departments to develop and implement systems for improved performance
- facilitating consultation between the Crown, its agencies, and iwi, hapu and Māori on sector-specific policies and practices.

Local intervention and risk management

This includes:

- providing early warnings of local, discrete issues that are likely to have a significant impact on the Crown-Māori relationship and, where Ministers consider appropriate, move to resolve the issues
- facilitating access by Māori, at a local level, to mainstream service delivery agencies.

Links Between Output Classes and the Government's Outcomes

The links between the output classes to be funded and the Government's outcomes are shown in the table below. All output classes contribute to the Government's objectives in the area of the Treaty of Waitangi, including:


- building relationships between the Crown and Māori

Part A2: Trends in Vote Māori Affairs

The Ministry of Māori Development (Te Puni Kokiri) was established on 1 January 1992 and inherited the functions and programmes of the Iwi Transition Agency (Te Tira Ahu Iwi) and Ministry of Māori Affairs (Manatu Māori).

The reduction in Vote Māori Affairs total appropriations from 1994/95 to the 1996/97 financial year reflects the mainstreaming of programmes inherited from Te Tira Ahu lwi. From 1997/98 the outputs supplied have increased reflecting the commencement of the Māori Development Commissions during 1997/98. Further increases in 1998/99 are due to the requirement to manage the 1997 and 1998 Māori Reserved Land Amendment Acts, and increased resources provided to undertake review and reform of Te Ture Whenua Māori Act 1993.

The 1999/2000 year sees a further increase in the Vote reflecting:

- the establishment of a pre-commercial facilitation service providing advice to Māori who wish to better utilise Māori land or establish business enterprises
- a significant contribution to the development of a Māori-owned national Māori registration service
- a new provider development fund to assist Māori organisations wishing to contract with the Government to provide social services.

Additional resources have been provided for the promotion of the Māori language, to increase the rate of revitalisation of the language and increase the number of people who are proficient in its use. In addition, Iwi/Māori housing support continues from its inception in 1998/99 through into 1999/2000.

The high level of Other Expenses in 1997/98 arose from a payment to Poutama Trust of the proceeds from the sale of Māori Development Corporation and the payment of compensation to lessees and lessors under the Māori Reserved Land Amendment Acts 1997 and 1998. These large payments were one-off appropriations.

Output Class D3 - Policy Advice - Māori Assets Management

Description

This class of outputs involves the purchase of analysis and policy advice on increasing Māori achievement in the development and management of assets, and on the linkages between Maori economic development outcomes and other outcomes for Māori. This will include strategic coordination and developing effective stakeholder relationships which contribute to Māori asset management and development outcomes.

In particular, advice will be purchased on:

 how to make progress towards closing the gap in economic status between Māori and non-Māori

- the management of Māori assets and ways to increase the capacity of Māori businesses
- increasing opportunities for Māori land utilisation by addressing Māori land fragmentation and utilisation issues
- customary Māori assets, including traditional fisheries
- the review and reform of the Te Ture Whenua Māori Act 1993.

In addition the Ministry will monitor and liaise with agencies which provide services that impact upon Māori assets and Māori economic development.

This class of outputs also includes the administration of Crown rural lending and land management advances to Māori people and Māori organisations, and of the receipt of Crown revenues collected by the Ministry. Administration of advances involves ongoing administration of the residual mortgage agreements.

Quantity, quality, timeliness and cost

Quantity

The Minister of Māori Affairs will expect work to be produced according to an agreed work plan, which will include projects as specified in the Purchase Agreement, and projects as required by Cabinet and Cabinet committees. The work plan may be updated from time to time during the year.

- All advice will be produced in accordance with the Ministry's Quality Assurance Handbook.

- how to make progress towards closing the gap between Māori and non-Māori in the labour market
- the development of strategies to increase employment opportunities for Māori in specific industry and occupational sectors
- the effectiveness of government policies and programmes in generating employment and training opportunities for Māori.

In addition, the Ministry will monitor and liaise with agencies which provide employment services to or for Māori, to ensure the adequacy of those services.

Quantity, quality, timeliness and cost

Quantity

The Minister of Māori Affairs will expect work to be produced according to an agreed work plan, which will include projects as specified in the Purchase Agreement, and projects as required by Cabinet and Cabinet committees. The work plan may be updated from time to time during the year.

Quality

- All advice will be produced in accordance with the Ministry's Quality Assurance Handbook.

Output Class D5 - Policy Advice - Relationships Between Māori People and the Crown

- partnership issues between the Crown and iwi, hapu and Māori

- information dissemination and consultation on significant issues between the Crown and Māori
- the ministerial oversight of the Māori Trust Boards
- Māori cultural heritage, including intellectual and cultural property
- international relationships and obligations which impact on Māori as the indigenous peoples of New Zealand.

In addition, the Ministry will monitor the Treaty relationship between Māori and the Crown, and the implementation of Waitangi Tribunal recommendations.

Quantity, quality, timeliness and cost

Quantity

The Minister of Māori Affairs will expect work to be produced according to an agreed work plan, which will include projects as specified in the Purchase Agreement, and projects as required by Cabinet and Cabinet committees. The work plan may be updated from time to time during the year.

Quality

The Minister of Māori Affairs will expect work to be produced according to the following quality standards:

- All advice will be produced in accordance with the Ministry's Quality Assurance Handbook.
- In reviews to be completed at least half-yearly, the Minister will assess the quality of advice provided as satisfactory or better and will assess no individual item of advice as poor in purpose, logic, accuracy, options, consultation, practicality, presentation, timeliness and overall satisfaction.
- In reviews to be completed half-yearly, independent experts will assess randomly selected examples of written policy advice as satisfactory or better in purpose, logic, accuracy, options, consultation, practicality and presentation.

Output Class D6 - Policy Advice - Māori Potential

Description

This class of outputs involves the purchase of analysis and policy advice on increasing the social and economic status of Māori families and communities, and on the factors which inhibit Māori from reaching their potential, and on issues not addressed in any other output class. This will include strategic coordination and developing effective stakeholder relationships which contribute to Māori social and economic outcomes.

In particular, advice will be purchased on:

- attracting finance for Māori entities
- family and community growth, with emphasis on how the whanau and hapu can be strengthened to promote social cohesion, personal safety and enhanced family values
- addressing Māori over-representation in the justice system, Māori crime prevention strategies and community-based rehabilitation
- the allocation of the Māori Provider Development fund to increase the ability of existing or potential Māori providers to deliver a range of social services contributing to whanau and community development
- a Māori development research strategy, which indicates research priorities for addressing disparities and promoting Māori development, and the results of research undertaken in line with this strategy.

In addition, the Ministry will monitor and liaise with agencies which provide social services to Māori to ensure the adequacy of their service delivery to Māori.

Quantity, quality, timeliness and cost

Quantity

The Minister of Māori Affairs will expect work to be produced according to an agreed work plan, which will include projects as specified in the Purchase Agreement, and projects as required by Cabinet and Cabinet committees. The work plan may be updated from time to time during the year.

Quality

The Minister of Māori Affairs will expect work to be produced according to the following quality standards:

- All advice will be produced in accordance with the Ministry's Quality Assurance Handbook.

- At least 75% of recipients surveyed in an annual programme of surveys approved by the Minister will assess the output class as satisfactory or better on average. No more than 10% of those surveyed will assess any output as poor in accuracy, relevance, accessibility and timeliness.
- At least five locations will be selected randomly and surveyed externally to ascertain that awareness and satisfaction levels are satisfactory or better.

Quantity: Specific projects as agreed with the Minister of Māori Affairs

and set out in the Purchase Agreement.

Quality: Completed to the satisfaction of the Minister of Māori Affairs.

Timeliness: All milestones achieved on dates specified.

Assessment of employees' Māori language proficiency

This project is designed to produce a range of valid and reliable tests or instruments to measure the Maori language proficiency of primarily government employees.

Quantity: The specific deliverables to be specified in the Purchase

Agreement between the Minister of Māori Affairs and Te Taura

Whiri i Te Reo Māori.

Quality: Completed to the satisfaction of the Minister of Māori Affairs.

Timeliness: All milestones achieved on dates specified.

Outputs in this class will be provided within the appropriated sum of \$2.371 million (inclusive of GST). The final 1998/99 appropriation was \$0.944 million (inclusive of GST).

Output Class O2 - Iwi Housing Support

This output class will provide:

 Operational support and management of agencies delivering Group Self-Build, an initiative to enable Māori whanau at risk to access affordable housing.

Quantity: Tendering contracts for up to 100 houses to be constructed.

Quality: Completed to the satisfaction of the Minister of Māori Affairs.

Timeliness: Contracts to be finalised by 30 June 2000.

Māori provider and iwi three-year housing development plan programmes to help iwi identify and develop housing solutions.

Significant progress towards the establishment of at least five Quantity:

new housing delivery agencies.

Quality: Completed to the satisfaction of the Minister of Māori Affairs.

Timeliness: All milestones achieved on dates specified.

Outputs in this class will be provided within the appropriated sum of \$0.301 million (inclusive of GST). The final 1998/99 appropriation was \$0.150 million (inclusive of GST).

Output Class O3 - Māori Pre-Commercial Facilitation Service

This output class will provide pre-commercial facilitation services for Māori business and land development to complement the current provision of programmes through the Business Development Programme.

The pre-commercial facilitation services will be purchased by the Board of the Māori Pre-commercial Facilitation Service from private providers and will be subject to individual contracts with each provider specifying the Services being purchased including the quantity, quality, location, timing and cost of those services.

Outputs in this class will be provided within the appropriated sum of \$1.350 million (inclusive of GST). This is a new appropriation.

Rangatiratanga Grants are for the promotion of Māori health, education, social and economic welfare.

Māori Provider Development Fund

The Māori Provider Development Fund enables the development of existing and new Māori providers so that they are able to tender competitively for service delivery contracts from purchasing agencies, and therefore increase the ability of Māori providers to contract to deliver a range of social services contributing to community and whanau development.

Māori Registration Service

The Government's contribution towards the establishment of the National Māori Registration Service will assist in linking Māori with their tribes, and will assist tribal groups in compiling comprehensive and accurate registers of their members.

Other

Māori Wardens, New Zealand Māori Council, Orakei Reserves Board Act 1991 and Payments to Trust Boards are all annual payments made to Māori organisations. Māori Wardens also includes payments made to meet the costs incurred by Māori wardens actively working with youth at risk.

Housing Corporation

Repayments received after the sale of the Māori Housing portfolio to the Housing Corporation of New Zealand are forwarded by way of the appropriation for payments to the Housing Corporation of New Zealand.
