Thank you for your Official Information Act request, received on 31 May 2018. You requested the following:

- "1. Pay-bands for graduate employees at Treasury for the years 2012 through 2018.
- 2. A breakdown of the qualifications earned by Treasury graduate employees from 2012 to 2018, including the proportion of Treasury graduate employees with an economics qualification (either a Bachelors degree majoring in economics, or a post-graduate degree in economics).
- 3. Recruitment strategy briefings provided to senior management from 2012 to 2018.
- 4. Any reports or briefings provided by external agencies (such as NZIER) assessing the quality of policy advice provided by Treasury to Ministers, in the last five years. "

On 6 June the Treasury sought clarification from you regarding question three and your email reply stated that you were "just interested in the metrics/criterion management are considering using to assess graduates."

The table below shows the pay bands for graduate employees at the Treasury (on appointment) for the years 2014 to 2018 as requested, and also includes our 2019 graduate cohort who were hired in 2018:

The above information does not show the proportion of graduates with economics degrees who applied, were shortlisted, interviewed and accepted job offers elsewhere.

The Treasury employs people with a broad range of analytical skills including those with graduate qualifications in Economics and Finance. A comprehensive graduate development programme is provided for all graduates, which includes training in Economics and Finance.

3. Shortlisting and selection criteria for assessing graduates when recruiting is below:

To apply applicants must:

- Be a New Zealand Citizen, Resident or Permanent Resident
- Have attained a B+ or higher grade average from previous 12 months' study
- Be ready to start at the specified date

The criteria for screening and shortlisting:

- Level of degree + grade average
- Interest in the Treasury and Graduate Analyst role
- Relevant experiences paid and volunteer
- Accolades
- Writing abilities
- Māori/Pacific capability
- Numerical literacy (psychometric testing)

In each of the Directorates where anticipated graduate vacancies will be, further information is provided on the specific skills and knowledge required for these individual roles, for example financial risk assessment papers, macroeconomics, public policy.

#### Criteria for Skype interviews:

- Working at the Treasury
- Analytical analysis (through a policy problem presentation)
- Working with others, for example cultural capability
- Self-management for example, prioritising work
- Ability to communicate

### Criteria for Assessment Day:

- Employment and academic reference checks
- · Written skills:
  - o Ability to communicate
  - o Analytical analysis through a policy problem proposal
- Group activity:
  - o Behavioural capabilities
  - Analytical analysis through a budget process simulation
  - o Panel Interview Analytical skills assessment: presentation
  - Graduate Analyst capabilities, for example problem solving, resilience, work environment
  - Self-development, for example constructive feedback, personal development preferences
- 4. Treasury provides advice to ministers on the quality of regulatory impact statements (RIS) where those RIS are likely to involve significant impacts or risks. This advice is contained in the quality assurance statement in the RIS and was included within the scope of the external evaluations of regulatory impact analysis carried out in 2012 and 2015. A search of Treasury records has not located any other reports by external agencies relating to the quality of policy advice provided by the Treasury to ministers.
