- [34] 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions
- [36] 9(2)(h) to maintain legal professional privilege
- [37] 9(2)(i) to enable the Crown to carry out commercial activities without disadvantage or prejudice
- [38] 9(2)(j) to enable the Crown to negotiate without disadvantage or prejudice
- [39] 9(2)(k) to prevent the disclosure of official information for improper gain or improper advantage

Title:	Enabling the Ministry for Women to Deliver on Government Priorities for New Zealand Women
Description:	This initiative will enable the Ministry for Women to deliver on Government priorities for New Zealand women. Funding has tracked lower than inflation over an extended period of time. This funding shortfall places increasing unsustainable pressure on the Ministry's ability to continue delivering quality services. Continuing increases in the cost of delivering policy and advisory services, and an increase in volume, have combined to place increasing and unsustainable pressure on the Ministry's baseline.
